

Ken Nugent – Teacher Scholarship Opportunity
Official Contest Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. HOW TO ENTER

- a. The Ken Nugent – Teacher Scholarship Opportunity contest will begin on July 1, 2007 at 8:00 AM Eastern Time (ET) and end on December 31, 2007 at 8:00AM Et.
- b. To participate in the contest, go to the Atlanta Falcons Radio website at www.atlantafalconsradio.com and register online. **A hyperlink will be available on the front page of www.atlantafalconsradio.com.** You must provide valid information with your first and last name, city, state, zip code, home telephone number, work telephone number, date of birth, and a valid email address. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an Internet access provider, online service provider or other organization that is responsible by assigning email addresses or the domain associated with the submitted email address. All entries must be received by December 30, 2007 at 8:00AM ET in order to be included in the final drawing. For purposes of these Official Rules, “receipt” of any online entry will be solely determined when the contest Administrator’s website server records the entry data. Any automated computer form reply or receipt (such as one confirming delivery of email) does not constitute actual receipt by Administrator of an entry form for purposes of these Official Rules. WZGC is not responsible for entries not received due to difficulty accessing the Internet, service outage or delays, computer difficulties or other technological glitches.
- c. A person may enter the Ken Nugent – Teacher Scholarship opportunity contest one time per valid internetl address. .

2. ELIGIBILITY RESTRICTIONS

- a. The contest is open to teachers working for an accredited K-12 school located in the State of Georgia. **Entrants must be full time teachers. Part Time Teachers and Subsitute Teachers are not eligible.** Entrants must be 18 years of age or older at the time of entry and reside in the State of Georgia. Employees of WZGC (the “Station”), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Atlanta metropolitan area and the members of their immediate families and/or households are ineligible to participate or win.

- b. Listeners are eligible to win a WZGC contest only once every ninety (90) days. Listeners are eligible to win a prize valued at \$600 or more only once every six (6) months. Only one winner per household is permitted in any Station contest.
- c. Winners must provide proof of eligibility and will be required to sign an affidavit of eligibility release form prior to acceptance of prize.
- d. Contestants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements, and the Station will also delete any entry received from persons under the age of 13 in compliance with the Children's Online Privacy Protection Act.

3. PRIZES

- a. A total of **20** winners will each receive a \$500 Scholarship in the form of a **check in the name of the winner** provided by Ken Nugent, Attorneys at Law, to be used to purchase school supplies.
- b. Winner is solely responsible for all applicable taxes. **[Winner may not want this burden. That's another reason to have the prize go to the school directly.]**
- c. All prizes or prize certificates must be picked up at the offices of WZGC Radio at the address below by January 30, 2008 and redeemed by March 30, 2008. The winner will forfeit any prize or prize certificate not timely claimed. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize or prize certificate. Winner must come to the CBS Radio offices to complete paperwork to claim prize.
- d. There is no substitution, transfer, or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of Station management with respect to the contest are final.
- b. Each winner will be selected in a random drawing of all eligible entries received as of the time of the individual winner selection. Selections will be conducted at approximately **2:00pm** ET on the Wednesday before each Atlanta Falcons Game beginning **August 8, 2007** and ending **December 26, 2007**.
- c. **ODDS OF WINNING DEPEND UPON THE NUMBER OF ENTRIES RECEIVED.**

- d. Winner need not listen or be present to win.
- e. Winners must execute and return any required Affidavit of Eligibility and/or Release of Liability Prize Acceptance Form within five (5) days of notification attempt or prize will be forfeited and an alternate winner may be chosen by random drawing of the remaining entries received up to that point. Winners will be notified via email and a follow up phone call following the drawing.

5. CONDITIONS

- a. Payments of all federal, state and local taxes are solely the responsibility of the winners. Winners may be required to sign an IRS Form W-9 or the equivalent.
- b. By participating in the contest, the winner or winners agree to have their name, voice, or likeness used in any advertising or broadcasting material relating to this contest without additional financial or other compensation, and, where legal, to sign a publicity release confirming such consent prior to acceptance of the prize.
- c. Prior to awarding any prize or prize certificate, the Station in its sole discretion may require contest winners (and their travel companions, if any) to sign a liability release, agreeing to hold the Station, its corporate licensee, its parent, subsidiary and affiliated corporations, and the officers, shareholders, directors, employees, agents and representatives of each of them harmless against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.
- d. The Station, in its sole discretion, reserves the right to disqualify any person tampering with the entry process, the operation of the Station's Web Site or is otherwise in violation of the rules. It further reserves the right to cancel, terminate or modify the contest if it is not capable of completion as planned, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort.
- e. The Station reserves the right to make changes in the rules of the contest, including the substitution of a prize of equivalent value, which will become effective upon announcement. If due to circumstances beyond the control of the Station, any competition or prize-related event is delayed, rescheduled, postponed, cancelled, or has a change of venue, the Station reserves the right, but not the obligation, to cancel or modify the contest and shall not be required to award a substitute prize.
- f. Failure to comply with the contest rules may result in a contestant's disqualification solely at the discretion of the Station.

- g. The Station is not responsible for typographical or other errors in the printing, the offering or the administration of the contest, or in the announcement of a prize.
