

WVEE (FM) V-103 Spondivits 30th Anniversary Jingle
Official Contest Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

- a. The Spondivits 30th Anniversary Jingle contest (the "Contest") will begin on Monday, July 6, 2009 at 6AM-Eastern Time ("ET") and end on Friday, July 17, 2009 at 5PM ET (the "Contest Period").
- b. **On Web:** To participate in the contest, you may enter via the following method(s): Log on to V-103.com and submit a 30 second or less **original jingle to for Spondivits. The jingles theme is "Spondivits's 30th Anniversary. The original jingle must include the key words Spondivits, V-103, Southside Atlanta and be positive** with all information requested by 5pm EST., Friday, July 17, 2009. Enter your first name and last name, complete address, city, state, zip code home telephone number and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address.
- c. **On Air:** Listen to Various Day Parts from 6AM-10PMET during the above mentioned dates for the cue to call. Upon hearing the cue to call, the one hundred and third (103rd) caller to reach the station's contest line at 404-741-9833 will win a **\$25 Spondivits gift card**, upon confirmation of eligibility. At the time of their call, callers must provide all information requested, including their full name, complete address, city, state and zip code, phone number, date of birth and a valid email. There will be a total of thirty cues to call during the Contest Period.
- d. The Station is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches.
- e. There is no limit to the number of times a listener may submit an entry, but a listener may only win once during this contest

1. **ELIGIBILITY RESTRICTIONS**

- a. The contest is open to all persons who are 18 years of age or older and who reside in the Atlanta metropolitan area and its surrounding counties. (the

“Station”), its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Atlanta metropolitan area and the members of their immediate families **AND/OR HOUSEHOLDS** are ineligible to participate or win.

- b. Only one winner per household is permitted in any Station contest.
- c. Contestants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entry from individuals who do not meet the eligibility requirements, and the Station will also delete any entry received from persons under the age of 13 in compliance with the Children’s Online Privacy Protection Act.

3. PRIZES

- a. One (1) Grand Prize winner will receive VIP dinner for 4 along with a very special guest at Spondivits Virginia Avenue. ARV: **\$200.00**
- b. Thirty (30) winners will each receive a \$25 Spondivits gift card. ARV: **\$25**
- c. All prizes or prize certificates may be picked up at the office of the Station at the address below. The winner will forfeit any prize or prize certificate not claimed within thirty (30) days of winning. In the event that a prize or prize certificate is mailed to the winner, it will be with the prior written consent of the winner and therefore, winner assumes the risk of its loss. The Station is not responsible for the safe arrival of a prize or prize certificate.
- d. There is no substitution, transfer, or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

- a. Decisions of Station management with respect to the contest are final.
- b. Winners will be selected as described above in section 1 of these Official Rules.
- c. Odds of winning depend on the number and order of phone calls received.

- e. Winners must execute and return any required Affidavit of Eligibility/Release of Liability Prize Acceptance Form by **Friday, July 17, 2009** or prize will be forfeited and an alternate winner may be chosen by random selection.
