

V103/Best Bank Website Contest
Contest Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. HOW TO ENTER

- a. The V-103 and Best Bank Web "Tip of the Month" contest will begin on Tuesday, January 1, 2008 at 6:00am Eastern Standard Time ("EST") and end on Thursday, January 31, 2008 at 5:00pm EST.
- b.** To participate in the contest participants must log onto www.V-103.com beginning Tuesday, January 1, 2008 and submit a web entry form with first and last name, complete address, daytime phone number and age. Deadline to enter is Thursday, January 31, 2008 at 5:00pm EST.
- c. Only one Internet entry per person and one Internet entry per email address are permitted. Duplicate entries will be disqualified. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an Internet access provider, online service provider or other organization that is responsible by assigning email address or the domain associated with the submitted email address.

All entries must be received by 5:00pm daily throughout length of contest. For purposes of these Official Rules, "receipt" of any on-line entry will be solely determined when the contest Administrator's website server records the entry data. Any automated computer form reply or receipt (such as one confirming delivery of email) does not constitute actual receipt by Administrator of an entry form for purposes of these Official Rules.

- d. WVEE is not responsible for entries not received due to difficulty accessing the Internet, service outages or delays, computer difficulties or other technological glitches.
- e. Limit one (1) entry per person.

2. ELIGIBILITY RESTRICTIONS

- a. The contest is open to all WVEE listeners who are 18 years of age or older and who legally reside in the Atlanta metropolitan area. Employees of WVEE, its licensee, its corporate parents, subsidiaries, and affiliates, its advertising agencies, participating sponsors/promotional partners, other radio stations in the Atlanta metropolitan area and the members of their immediate and/or household are ineligible to participate or win.

b. Only one winner per household is permitted in any contest.

c. Contestants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. WVEE will also disqualify any entry received from person under the minimum specified age for this contest and will also delete the entries received from any person under the age of 13 in compliance with the Children's Online Privacy Protection Act.

3. PRIZES

a. One (1) prize will be awarded consisting of one (1) \$500 Gift Card from Best Bank (ARV:\$500)

Prizewinners must pick up prizes at WVEE offices by 5:00pm EST Thursday, January 31, 2008 or prizes are null and void. WVEE is not responsible for the safe arrival of a prize.

c. There is no substitution, transfer, or cash equivalent for prizes, except that Sponsor may, at its sole discretion, substitute prizes of comparable value or cash due to prize unavailability or where required by law. a. Decisions of WVEE management with respect to the contest are final.

b. WVEE will randomly select 1 winner Thursday, January 31, 2008 at 5:00pm EST from among all eligible entries received.

c. Winners need not listen or be present to win. Winners will be contacted by telephone within 3 days following the selection of winners. If any winner cannot be reached within 3 days of notification attempt, that winner forfeits his/her prize and an alternate winner may be selected by random drawing from the remaining eligible entries.

d. Winners must execute and return any required Affidavit of Eligibility/Release of Liability Prize Acceptance Form within two (2) days of notification attempt or prize will be forfeited and an alternate winner may be chosen by random selection.

5. CONDITIONS
